- III. COMMITTEE REPORTS

 - C. Product Evaluation Michael Fox
 - ➤ Mr. Fox explained the product approval system in the 2010 Florida Building Code: the two options are revision and self-affirmation. Revisions takes longer, as it requires the submission of technical information to the state, whereas the self-affirmation simply requires the statement that it meets the code.
 - ➤ <u>Ms. Caldwell</u> said that Palm Beach County has decided that it will continue to accept product approvals for an additional 30 days, provided they are not outdated and have not had major changes in their testing.

D. Regulatory Climate Oversight Committee – Rebecca Caldwell

- Ms. Caldwell reported that a second reminder letter was sent to the municipalities that have not yet answered. Currently we have seventeen (17) positive, and nine (9) negative. We have asked industry to speak to these municipalities and some of them have asked additional questions, so perhaps they are rethinking it, thanks to industry.
- > Chairman Higgins asked to hand out a copy of the list.
- ➤ Mr. Wise offered to speak with Andy Lucasik of the City Managers Association of Palm Beach County, to see what can be done with those who are not participating.

IV. NEW BUSINESS

1. 2010 FBC Wind Provisions - Richard Gathright

- Mr. Gathright showed his presentation on the new Florida Building Code windmaps, explaining the changes on higher windspeeds and change in wind-borne debris regions. He also described the impact of ASCE7-10 on load combinations and design wind loads and the risk categories of buildings and structures.
- Ms. Caldwell elaborated on the "wind-borne debris region", and stated that by local amendment, we have declared all of Palm Beach County a wind-borne debris area.

2. Shed Update to New Code - Michael Fox

- Mr. Fox told the Board that included in the packet was a drawing showing the slight changes in the shed drawing, to reflect 2010 FBC. They fall into Risk Category 1 and the strength design pressure is Exposure C.
- > Chairman Higgins questioned the lack of notation on mesh with slab.
- > Ms. Caldwell motioned to approve the drawings, adding Mr. Higgins' suggestion to revise to include fiber or welded wire mesh.
