## III. OLD BUSINESS

## A. 18-10 - 1189 ROSEBUD LANE - MIA REAL HOLDINGS LLC

Mr. Wise summarized the case as previously heard before the Board. He stated that there were on-going inspections, and the appellant filed revisions as recently as the week prior to the hearing.

There was no appearance on behalf of the Appellant.

Board questioned staff. Discussion ensued.

- + Mr. Oyola made a motion to grant an additional 90 days being that the Appellant is complying with the Building Official and doing what they said they would do so far. Ms. Walden seconded the motion.
  - Ms. Fox clarified if the motion meant that if the construction was not completed in the 90 days, then the Building Official would proceed with demolition.
- + Mr. Oyola affirmed the clarification to the motion without restating it. Ms. Walden affirmed her second of the motion. There was no further discussion. The motion carried unanimously.

#### B. 19-07 – 15924 82<sup>nd</sup> Lane – Tenisha Blair

There was no appearance on behalf of the Appellant.

County Attorney and Board members questioned Staff and discussion ensued.

4- Ms. Walden made a motion to grant a 90-day extension whereby there needs to be a definitive improvement in terms of permitting for all of the non-permitted work that was conducted, and if not then demolition will be instituted.

Discussion ensued.

At Ms. Fox's request for clarification, Mr. Wise suggested an amendment to the motion that permit applications be filed for the scope of work performed without permit to include, but not be limited to structural, mechanical, and plumbing work.

4- Ms. Walden was amenable to the amendment to the motion without restating it. Mr. Markel seconded the amended motion. There was no additional discussion. The motion carried unanimously.
