B. APPROVAL OF MINUTES

3. NEW BUSINESS.

Assistant County Attorney Shannon Fox swore in all those giving testimony.

Case 15-07 – 1012 Highview Rd, Lantana, FL 33462 – Gary and Ruth Marcinkoski

Building Official Doug Wise submitted the Building Division's Staff Report into evidence and presented the case to the Board. He stated that the home was hit by a car in May 2015. He indicated that the damage was initially thought to be a simple repair, but after investigation, the home was found to have substantial termite damage. He affirmed that the property owner requested additional time to repair the structure the request was granted to the extent allowable under the code, but Mr. Wise was unable to approve any additional extension of time so as not to set precedence for similar types of cases. He asked that the Board hear the testimony of the homeowner to judge the case on its own merits as to whether additional time

extension should be granted. Mr. Wise also stated that a permit application was filed on August 7th and was still undergoing review. He stated that the property is a rental property and not owner occupied.

Gary Marcinkoski, homeowner, testified on his own behalf. He stated that it took time for him to get the tenants out of the house. He indicated that he had an engineer draw up plans and hired a contractor. The plans were submitted five weeks before the hearing. He affirmed that the home was vacant, boarded up and secured from use. He stated that he believed he was moving as quickly as possible. He testified that he intends to complete all the repairs once the permit is issued, and he requested an additional six months to complete the repairs.

Discussion ensued among the Board members, the property owner, and County staff.

A motion was made and seconded to grant the property owner eight months from the date of the hearing (September 10, 2015) to get a permit and complete the repairs on the home. The motion passed unanimously.
