A. 17-08 - 22769 N Bay Cir - Ozer Feyzioglu

Mr. Wise requested the County Staff Report be admitted into evidence.

Mr. Wells stated the case involves a double-wide mobile home damaged by fire. The Appellant has hired a contractor and engineer and applied for a permit. Application number PR-2017-018330.

Discussion ensued.

Mr. Rasper made a motion to grant a six-month extension per Staff recommendation. Mr. Dixon seconded the motion.

Discussion ensued.

Mr. Rasper amended the motion to grant the Appellant 60 days to obtain a permit and six months to obtain final completion. Mr. Dixon seconded the amended motion. The motion passed unanimously.

B. 17-09 – 10236 Harbourtown Ct – Doron Nissim

Mr. Wise provided a history of the property which was presented to the Board twice before. The first appeal submitted by Shamrock LLC was denied. The second appeal was dismissed when the Appellant Deutsche Bank failed to appear.

Discussion ensued.

Mr. Wise requested the County Staff report be admitted into evidence.

Mr. Green introduced himself as the contractor hired by the Appellants. He stated he believes the structure is reparable. Mr. Green requested 60 days to obtain drawings from engineer and a permit and 3 months to complete and obtain CO (Certificate of Occupancy).

Mr. Kirby made a motion to grant the Appellant 60 days to obtain a permit and return before the Board at the 60-day mark to provide an update to the Board. Mr. Markel seconded the motion. The motion passed unanimously.
