

# Palm Beach County CONSTRUCTION BOARD OF ADJUSTMENT AND APPEALS (CBAA) AUGUST 11, 2022 MEETING

- A. 2021-06 and 2022-07 48 Norwich B and Norwich Condominium Association
- Mr. Wise asked Mr. Henriques for an update on Jorge Fernandes living situation.
- + Mr. Henriques informed the board and Mr. Wise that Jorge is still homeless and nothing has changed.

+ Mr. Perl went over the Exhibits he submitted for the board to view i.e Licensing and Insurance, COI, the agreement between contractor and association, and stated the funding is still pending.

#### Discussion Ensued

Mr. Oyola added an amendment that may give them time to get their funding together as Mr. Wise said earlier it can be 90-100 days before anything could be worked out. So in that period of time, it can give them the opportunity to get the funding that they need and permits needed and everything in place. Mr. Rasper seconded the motion. The motion carried unanimously.

#### IV. NEW BUSINESS

- A. 2022-04-6525 Oriole Blvd APT 107 (Wrights Windows and Door)
- Mr. Wise states that this is an issue that occurred during plan review and the company is trying to get their permit issued.
- Michael Fox explained to the board that the length of the mullion is what drew our intention. There is a product approval for that size mullion that would meet the pressure but not the length. That's what got us asking for more information.

- → My Oyola made a motion to deny the variance. Mr. Rasper seconded the motion. The motion carried unanimously.
- B. 2022-05- 4498 Thornwood Circle
- Tom Banzhaf stated this is a 2 story attached townhouse that one of the owners has vandalized both exterior and interior. An unsafe building inspection was performed on May 03, 2022, and noted the extent of damage to the structure.

Discussion Ensued

- Mr. Wise asked that the staff report be admitted into evidence.
- Staff is recommending 30 days to get repairs and the appellant is asking for more time to find a contractor and have a contract with them.

Mr. Oyola made a motion to grant 30 days and come back with a contractor or contract to sell the property. Mr. Wingate seconded the motion.

- + Mr. Dixon amended the motion and made a motion to grant them 60 days and come back with a contracted contractor or contract to sell the property. Mr. Wingate seconded the motion. The motion carried unanimously.
- C. 2022-06- Harbour Star Drive-Neptune Docks LLC
- → Mr. Wise asked that the staff report be admitted into evidence.
- ★ Tom Banzhaf stated this was reported from the commissioner's office about an unsafe structure. Code enforcement went out and took photos of the structure.
