2. APPROVAL OF MINUTES

Ms. Walden made a motion to approve the minutes of May 11, 2017. Mr. Oyola seconded the motion. The motion carried unanimously.

3. OLD BUSINESS

Ms. Anderson previously administered an oath during the CBAA meeting to all witnesses.

A. 17-02 – Anand Poonai, CGC-1508344 & CCC-1326958 (DBA Dcota Contracting, Inc.)

The case was before the Board previously. The Board initially found the Respondent guilty willful code violation and fraud, and postponed the penalty phase for 30 days to allow the Respondent an opportunity to work out an agreement with the homeowner.

Subsequently, the Board granted an additional 90 days to complete the work and return before the

The County Staff Report contains the dates of all the visits to the property and case information. Staff recommended the Board grant the Respondent another 30 days to work through one issue outstanding identified in the most recent inspection.

Mr. Wise requested to enter the County Staff Report into evidence.

The electrical contractor submitted a permit application to remove the unpermitted work the day before the hearing.

Mr. Poonai stated CJ Electric was unaware a permit was needed to remove the unpermitted work.

Discussion ensued.

Mr. Rasper made a motion to grant the Respondent 30 additional days to complete any outstanding issues and come back before the Board.

Mr. Sullivan seconded the motion.

The motion carried unanimously.
