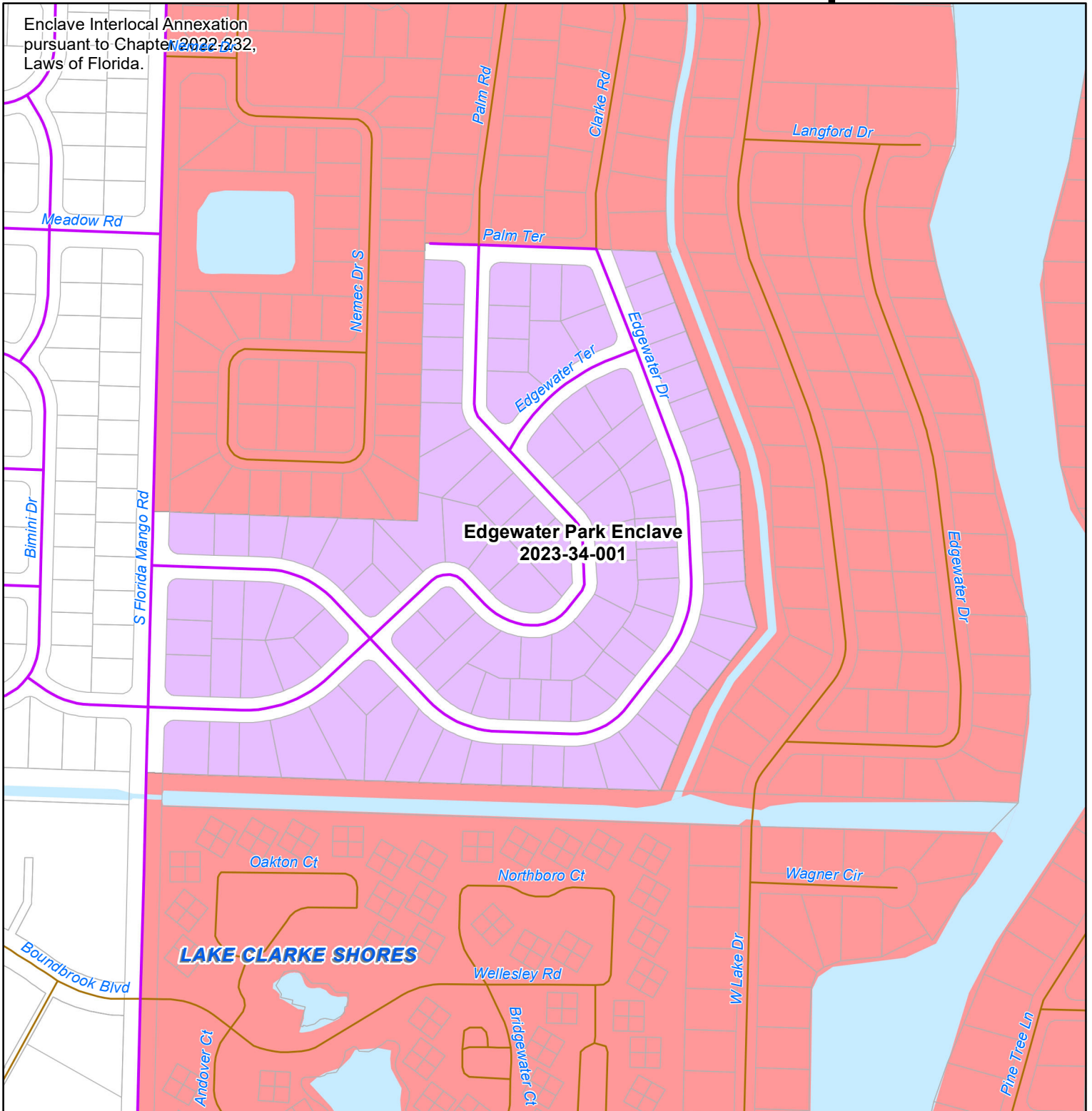

Enclave Interlocal Annexation pursuant to Chapter 2022-232, Laws of Florida.



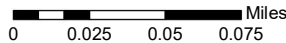

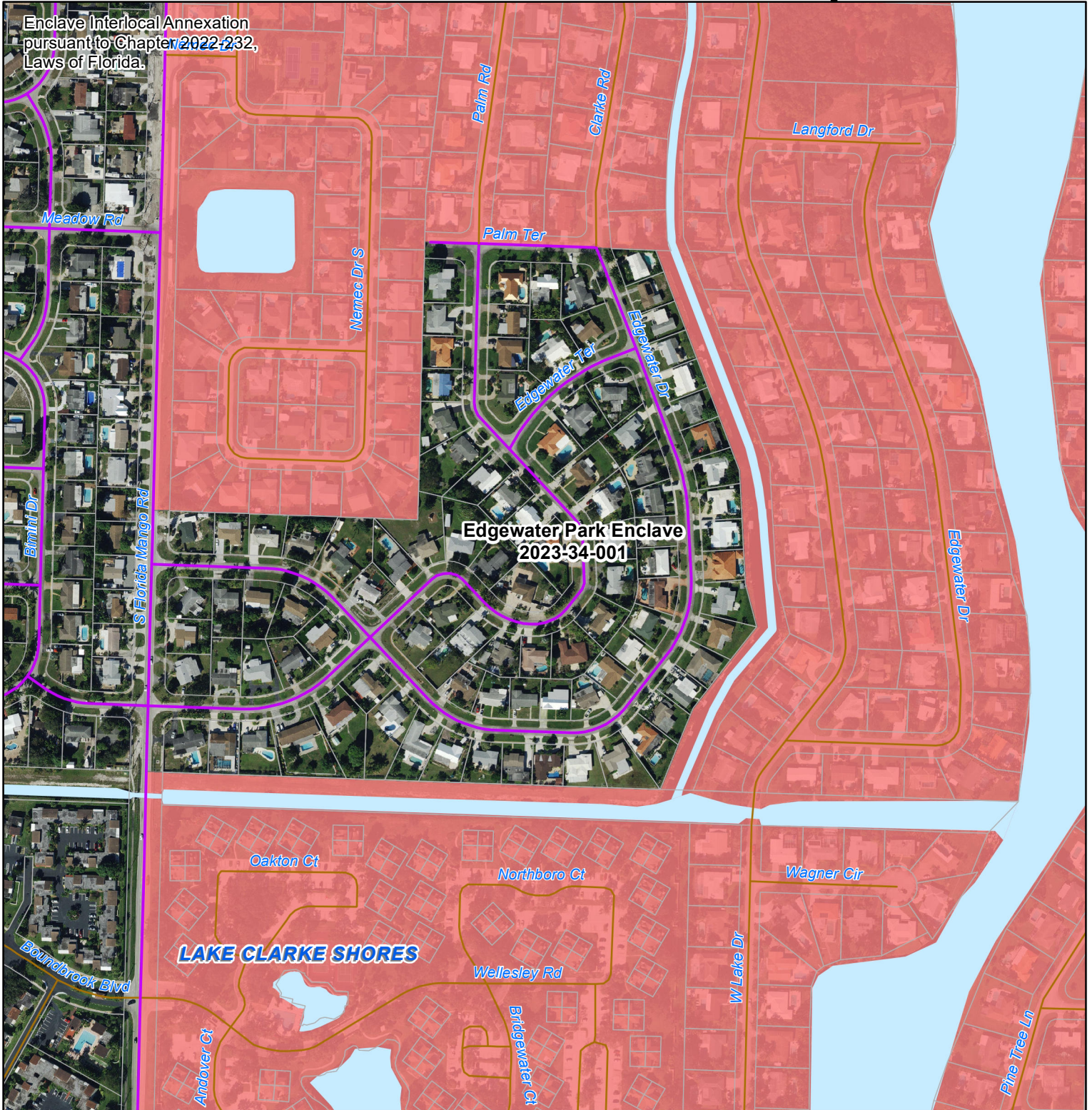

# Annexation Location Map



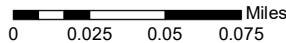

**RESOLUTION 2023-32**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LAKE CLARKE SHORES, FLORIDA, AUTHORIZING THE MAYOR TO EXECUTE AN INTERLOCAL AGREEMENT BY AND BETWEEN PALM BEACH COUNTY AND THE TOWN OF LAKE CLARKE SHORES PURSUANT TO SECTION 171.046, FLORIDA STATUTES, AND CHAPTER 2022-232, LAWS OF FLORIDA, FOR THE ANNEXATION OF AN ENCLAVE KNOWN AS EDGEWATER PARK CONSISTING OF 98 PARCELS TOTALING LESS THAN ONE HUNDRED AND TEN ACRES, AS MORE FULLY DESCRIBED IN THE ATTACHED INTERLOCAL AGREEMENT; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**

**WHEREAS**, pursuant to Chapter 2022-232, Laws of Florida, the Legislature of the State of Florida found the territory comprising a portion of Edgewater Park and adjoining canals and of approximately 32.768 acres in land area is an enclave of the Town of Lake Clarke Shores for all purposes of municipal annexation under Part I of Chapter 171, Florida Statutes; and

**WHEREAS**, said enclave is comprised of 98 individual parcels of land amounting to less than one hundred ten acres in total size; and

**WHEREAS**, the Town Council of the Town of Lake Clarke Shores desires to annex said enclave into the Town; and

**WHEREAS**, Section 171.046, Florida Statutes provides that such enclave may be annexed into the Town pursuant to an Interlocal Agreement between the Town and Palm Beach County; and






## INTERLOCAL AGREEMENT

**THIS INTERLOCAL AGREEMENT** is made on this \_\_\_\_ day of \_\_\_\_\_, 2023 between the TOWN OF LAKE CLARKE SHORES, a municipal corporation located in Palm Beach County, Florida, hereinafter referred to as "TOWN," and PALM BEACH COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "COUNTY", each entity constituting a "public agency" as defined in Part 1, Chapter 163, Florida Statutes (2023).

**WHEREAS**, Section 163.01, Florida Statutes (2023), known as the "Florida Interlocal Cooperation Act of 1969," as amended, authorizes local governments to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage, and to thereby provide services and facilities which will harmonize geographic, economic, population and other factors influencing the needs and development of local communities; and

**WHEREAS**, the "Florida Interlocal Cooperation Act of 1969" permits public agencies as defined herein to enter into interlocal agreements with each other to jointly exercise any power, privilege, or authority which such agencies share in common and which each might exercise separately; and

**WHEREAS**, Section 171.046, Florida Statutes (2023), provides for annexation of certain enclaves by entering into an interlocal agreement between the municipality and the county having jurisdiction over such enclave; and

**WHEREAS**, Section 171.046, Florida Statutes (2023), limits annexation by interlocal agreement to enclaves of 110 acres or less in size; and

**WHEREAS**, pursuant to Chapter 2022-232, Laws of Florida, the Legislature of the State of Florida found that the territory comprising a portion of Edgewater Park and adjoining canals consisting of approximately 32.768 acres in land area shall be considered an enclave of the Town of Lake Clarke Shores for all purposes of municipal annexation under Part I of Chapter 171, Florida Statutes; and

**WHEREAS**, the County and the Town have determined that it is appropriate and will promote efficient provision of governmental services for the Town to annex the certain enclave; and

**WHEREAS**, the County and the Town have determined that the parcels to be annexed by way of this Interlocal Agreement meet the requirements set out in Section 171.046, Florida Statutes (2023), and Chapter 2022-232, Laws of Florida, because such enclave is developed or is improved, and is 110 acres or less in size; and

**WHEREAS**, the enclave identified for annexation in this Interlocal Agreement is in the Town's future annexation area; and

**WHEREAS**, the County and the Town agree that the parcels to be annexed by way of this Interlocal Agreement are subject to the Land Use Atlas of the Palm Beach County Comprehensive Plan and County zoning and subdivision regulations until the Town adopts a comprehensive plan amendment to include the parcels to be annexed into the comprehensive plan.

**NOW, THEREFORE**, in consideration of the mutual representations, terms, and covenants hereinafter set forth, the parties hereby agree as follows:

**SECTION 1. PURPOSE.** The purpose of the Agreement is to allow annexation by the Town of Lake Clarke Shores of a certain unincorporated enclave which is identified in Exhibit "A" attached hereto and made a part hereof.

**SECTION 2. DEFINITIONS.** The following definitions shall apply to this Agreement:

1. The term "enclave" shall be defined as set forth in Section 171.031(13), Florida Statutes and Chapter 2022-232, Laws of Florida.
2. "Act" means Part 1 of Chapter 163, Florida Statutes (2023).
3. "Agreement" means this Interlocal Agreement, including any amendments or supplements hereto, executed and delivered in accordance with the terms hereof.

**SECTION 3. ANNEXATION.** The unincorporated enclave identified in Exhibits "A" and "B", which are attached hereto and made a part hereof, are hereby annexed into and are included in the corporate boundaries of the Town of Lake Clarke Shores.

**SECTION 4. ANNEXATION OF RIGHTS-OF-WAY, CANAL, AND OTHER GOVERNMENT SERVICES.** Palm Beach County hereby consents to the annexation of the right-of-way segments and canal and the transfer of government services identified in Exhibit "C" into the corporate boundaries of the Town of Lake Clarke Shores.

**SECTION 5. TRANSFER OF OWNERSHIP AND MAINTENANCE RESPONSIBILITY OF RIGHTS-OF-WAY IDENTIFIED IN EXHIBIT "C".** Approval of this Agreement by both parties constitutes mutual agreement by the Town and County pursuant to Section 335.0415, Florida Statutes (2023), to the transfer of the responsibility for ownership, operation and maintenance of the right-of-way segments identified in Exhibit "C" from the County to the Town. Such transfer shall occur upon the effective date of this agreement.

**SECTION 6. EFFECTIVE DATE.** This agreement shall take effect upon execution by both parties.

**SECTION 7. FILING.** Upon execution by both parties, a certified copy of this Agreement shall be filed with the Clerk of Circuit Court in and for Palm Beach County.

**SECTION 8. CAPTIONS.** The captions and section designations herein set forth are for convenience only and shall have no substantive meaning.


**SECTION 9. SEVERABILITY.** In the event any section, paragraph, sentence, clause, or provision hereof is held by a court of competent jurisdiction to be invalid, such shall not affect the remaining portions of this Agreement, and the same shall remain in full force and effect.


**SECTION 10. ENTIRE AGREEMENT AND COUNTERPARTS.** This Agreement represents the entire understanding between the parties, concerning the subject, and supersedes all other negotiations, representation, or agreements, either written or oral, relating to this Agreement. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

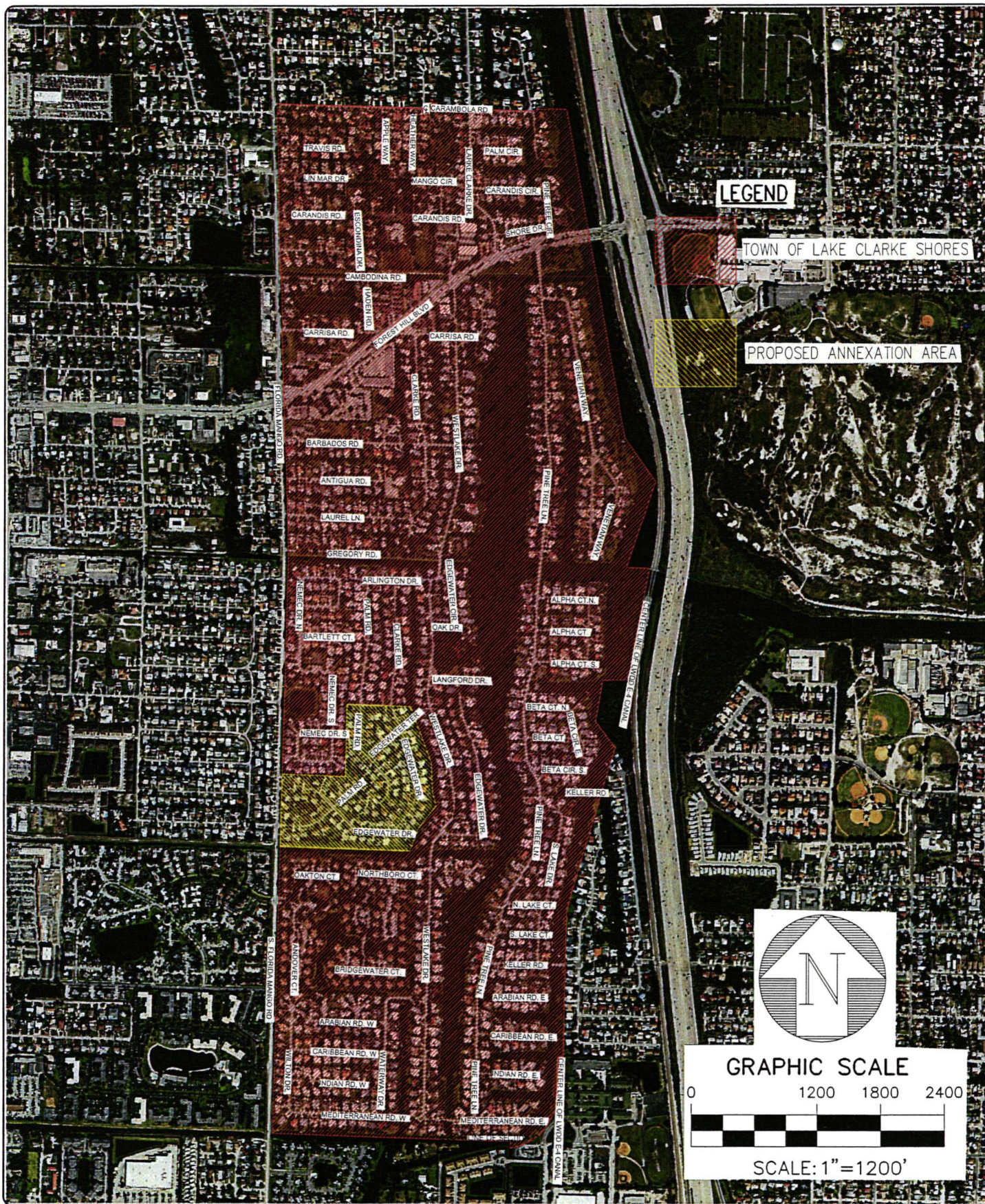
