REQUEST FOR ZONING CONFIRMATION URBAN REDEVELOPMENT AREA (URA) OPT OUT

Pursuant to Unified Land Development Code (ULDC), Article 3.B.16.B, Urban Redevelopment Area (URA) Overlay, a property owner may request to utilize the Future Land Use (FLU) and Zoning of a property that was in place prior to the adoption of the Urban Infill (UI) and Urban Center (UC) future land use designations and zoning in August 2010. The prior zoning district must be consistent with the prior future land use designation per the Future Land Use Element in the Comprehensive Plan. Planning staff will confirm findings through a Letter of Determination.

Submit this signed and notarized Request for Zoning Confirmation with the Pre-Application Review (PAR) Request and the Planning Letter of Determination through the online portal. Following staff review, the Zoning Division will issue a letter to confirm the utilization of the Alternative Zoning District for the property(s).
