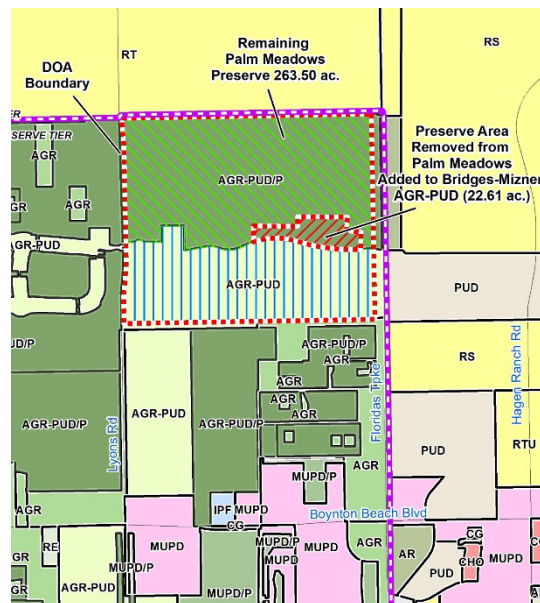

Summary:	<p>This application is for the Palm Meadows AGR-PUD. The AGR-PUD was approved by the Board of County Commissioners (BCC) for 277 residential dwelling units, and was most recently modified by the BCC on January 11, 2023.</p> <p>The request proposes to modify the overall Master Plan to delete 22.61 acres of Preserve Area that will be added to the Bridges-Mizner AGR-PUD as a new Preserve Area by concurrent Application DOA-2024-01918. The deleted land area will also modify the boundaries of the previously approved requested use for Grooms Quarters from 286.17 acres to 263.56 acres. The overall acreage will be reduced to 439.28 acres.</p> <p>There is no change proposed to the number of residential dwelling units.</p>
