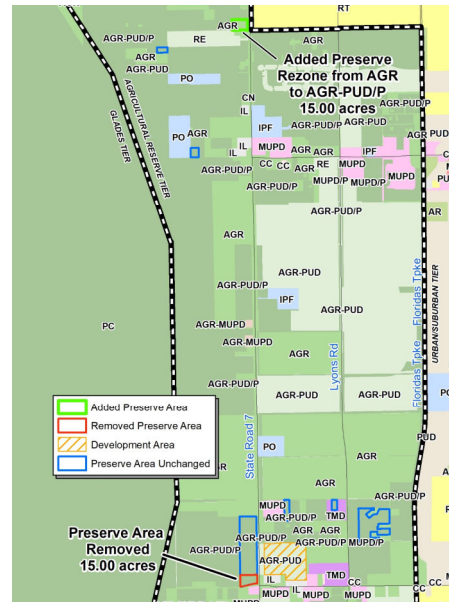

Summary:

The application is for the Ascot 441 Atlantic AGR-PUD. The development was approved as an Agricultural Reserve Planned Unit Development (AGR-PUD) by the Board of County Commissioners on September 30, 2004.

This request proposes to modify the overall Master Plan to delete a portion of Preserve Parcel 1 (15.00 acres) located at the northwest corner of Atlantic Avenue and State Road 7 and to replace this acreage with the addition of a new 15.00 acre Preserve parcel located further north on the west side of State Road 7, approximately 1.34 miles south of Hypoluxo Road. This application includes an Official Zoning Map Amendment request to rezone the added land area from Agricultural Reserve (AGR) to AGR-PUD as a preserve parcel. The deleted land area would be rezoned from AGR-PUD to AGR through concurrent application Z-2024-01925.

There are no changes to the overall acreage figures on the Preliminary Master Plan (PMP) which indicates 130.22 acres of Development area and 200.38 acres of Preserve area on a total of 330.60 acres. There are no proposed changes to the Development Area or the other five Preserve parcels.
