RESOLUTION APPROVING ZONING PETITION

Benton Harrison, President, for a SPECIAL EXCEPTION TO ALLOW A RESTAURANT OVER FIVE THOUSAND (5,000) SQUARE FEET on Lots 32, 33, 34, 35, 36 and 37, less the North 100 feet of Lots 32, 33 and 34 and less the East 3.0 feet of Lots 34 and 35, revised plat of Merlin Park, recorded in Plat Book 23, page 124. Said property located at the northwest corner of the intersection of Military Trail (S.R. 809) and Myrtle Lane in a CG-General Commercial District, was approved as advertised subject to the following special conditions:

- 1) Approval of revised site plan depicting acceptable landscaping;
