## RESOLUTION APPROVING ZONING PETITION .

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 73-73 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 28 June 1973.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 28th day of June, 1973 , that petition No. 73-73, the petition of KNIGHTS OF COLUMBUS BUILDING ASSOCIATION OF WEST PALM BEACH, FLORIDA, by Thomas J. Yeager, Vice President, for the REZONING, FROM RH-RESIDENTIAL MULTIPLE FAMILY DISTRICT (HIGH DENSITY) TO CG-GENERAL COMMERCIAL DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A PRIVATE CLUB FACILITY AND A COMMERCIAL RESTAURANT AND LOUNGE EXCEEDING 5,000 SQUARE FEET OF FLOOR AREA, on a tract of land in the Southeast 1/4 of Section 30, Township 43 South, Range 43 East, described as follows: commencing at the Southeast corner of Section 30 and run North 87° 58' 54" West along the South line of Section 30, a distance of 1747.09 feet; thence North 2° 00' 51" East, a distance of 519.34 feet to the Point of Beginning; thence continue North 2° 00' 51" East a distance of 580.66 feet; thence North 87° 58' 54" West, a distance of 349.10 feet; thence South 2° 00' 51"
