Schaefer, Agent, for a SPETCAL EXCEPTION TO ALLOW A TENNIS CLUB PLANNED UNIT DEVELOPMENT on the Northwest 1/4 of the Northwest 1/4 of Section 24, Township 43 South, Range 42 East. Said property located on the east side of Haverhill Road approximately .8 mile north of Okeechobee Boulevard (S.R. 704) in an RM-Residential Multiple Family District (Medium Density), was approved as advertised subject to the following special conditions:

(1) In the event that the final alignment of 12th Street abuts the north boundary of the project, the required right-ofway shall be dedicated, to Palm Beach County, by the developer;

- (2) The project entrance road shall be signalized, if required by the County Engineer and at the developer's cost;
- (3) Legal positive outfall to be provided prior to platting,
