Keathley, President, for a SPECIAL EXCEPTION TO ALLOW A CLUB HOUSE AND SHUFFLE BOARD COURTS on the North 240 feet of the West 400 feet of the East 1/2 of the Northeast 1/4 of the Northwest 1/4 of Section 26, Township 44 South, Range 42 East, excepting, however, the North 90 feet thereof, for rights-of-way for L.W.D.D. Lateral Canal No. I,-12 and Lake Worth Road (S.R. 802). Said property located on the south side of Lake Worth Road (S.R. 802) approximately one (1) mile west of Military Trail (S:R. 809) in a CG-General Commercial District, was approved as advertised subject to the following conditions:
