

RESOLUTION NO. R-73- 717

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 73-201 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 25 October 1973.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 25th day of October, 1973, that petition No. 73-201, the petition of THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY by Lake Lytal, Chairman, for the REZONING, FROM AG-AGRICULTURAL DISTRICT IN PART AND RS-RESIDENTIAL SINGLE FAMILY DISTRICT IN PART TO PO-PUBLIC OWNERSHIP DISTRICT of the West 1/2 of Tract 2, Tracts 5 and 6, the West 1/2 of Tract 7, Tracts 8, 12, the West 3/4 of Tract 13 and Tracts 17 and 18, Block 2, Palm Beach Farms Company Plat No. 3 in Sections 29, 30, 31 and 32, Township 43 South, Range 42 East as recorded in Plat Book 2, page 46. Said property located on the north side of Belvedere Road approximately .7 mile east of State Road No. 7, containing 235 acres, more or less, was approved as advertised.
