RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 73-216 was presented **to the** Board of County Commissioners of Palm Beach County at its public hearing conducted on 29 November 1973.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session November, 1973 , that petition this 29th day of No. 73-216, the petition of PALM BEACH BAPTIST TEMPLE, INC., by Reverend Lee Ryder, President, for a SPECIAL EXCEPTION TO ALLOW A CHURCH AND ACCESSORY FACILITIES on the South 1/2 of the Northwest 1/4 of the Northeast 1/4 of the Northwest 1/4 of Section 1, Township 45 South, Range 42 East, less the East 39.34 feet of the South 116 feet thereof; and the South 1/2 of the Northeast 1/4 of the Northeast 1/4 of the Northwest 1/4 excepting therefrom the South 220 feet and the rightof-way of Military Trail (S.R. 809); also a right-of-way for ingress and egress over the North 30 feet of the South 3.50 feet of the South 1/2 of the Northeast 1/4 of the Northeast 1/4 of the Northwest 1/4 all in Section 1, Township 45 South, Range 42 East. Said property located on, the west side of MilitaryTrail (S.R. 809) approximately 3/4 mile north of proposed Hypoluxo Road in an AG-Agricultural District,

was approved as advertised subject to the following special conditions:

- Developer shall construct, at his expense, the required left and right turning lanes onto Military Trail (S.R. 809);
- 2) Prior to the issuance of any building permits the developer shall deed to Palm Beach County the additional right-of-way required to provide for a one hundred twenty (120) foot right-of-way for Military Trail (S.R. 809) and the forty (40) feet for a limited access road. The total of the rightsof-way being one hundred (100) feet from the centerline of Military Trail (S.R. 809).
