## RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 73-244 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 4 January 1974.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session January, 1974 , that petition this 4th day of No. 73-244, the petition of MULTIPLE CHOICE REALTY INVESTMENTS, INC., by Claudette Bruck, President, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RE-RESIDENTIAL ESTATE DISTRICT of a portion of Tracts 27, 28, 29, 30 of Florida Fruit Lands Company Subdivision No. 2 of Section 19, Township 47 South, Range 41 East, as recorded in Plat Book 1, page 102; together with a portion of the Northeast 1/4 of Section 30, Township 47 South, Range 41 East, being more particularly described as follows: beginning at the Southwest corner of the said Northeast 1/4 of Section 30; thence South 89° 48' 54" East along the South line of said Northeast 1/4, 680.90 feet to the Point of Beginning of this description; thence continue South 89° 48' 54" East along the last described line, 733.14 feet to a point; thence North 0° 20' 46" West 3632.83 feet to a point on the South right-of-way line of

State Road No. 827, as claimed by the State Road Department; thence North 71° 39' 51" West along the said South right-of-way line, 340.64 feet to a point; thence North 0° 38' 53" West 26.44 feet to a point; thence North 71° 39' 51" West 432.90 feet to a point; thence South 0° 20' 46" East 3899.71 feet to the Point of Beginning.
