RESOLUTION APPROVING ZONING PETITION

MINKER by Lee Starkey, Agent, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RE-RESIDENTIAL ESTATE DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A PLANNED UNIT DEVELOPMENT on the East 60 feet of Tract 4, all of Tracts 9 and 10, less the North 287.82 feet of the East 426.7 feet of Tract 10; the East 60 feet of Tract 11, less the South 372.18 feet; the East 289.98 feet of the South 372.18 feet of Tract 11, all of Tracts 18 to 21 inclusive; 23 to 26 inclusive; 32 to 40 inclusive; and 45 to 54 inclusive; all in Block 27, Palm Beach Farms Company Plat No. 3 in Sections 30 and 31, Township 44 South, Range 42 East as recorded in Plat Book 2, page 48, Said property located approximately 600 feet south of Lake Worth Road (S.R. 802) on the east side of State Road No. 7, was approved as advertised, subject to the following special conditions:


- 1) When traffic warrants, the developer shall construct, at his expense, the left and right turn lane on Lake Worth Road at the developments entrance;
