## RESOLUTION APPROVING ZONING PETITION

McLean, Attorney-in-Fact, for a SPECIAL EXCEPTION TO ALLOW THE DRILLING OF AN EXPLORATORY WELL TO TEST FOR PETROLEUM AND ASSOCIATED PRODUCTS on the following described parcel of land in Section 7, Township 46 South, Range 35 East: commencing at the Southeast corner of said Section 7; thence South 89° 41' 31" West with the South line for a distance of 1321.32 feet; thence Morth Olo 10' 40" West 1141.0 feet; thence North 89° 45' East 330.0 feet to the Point of Beginning of the herein described tract; thence South 89° 45' West 660.0 feet; thence North 00° 15' West 660.0 feet; thence North 89° 45' East 660.0 feet; thence South 00<sup>b</sup> 15' East 660.3 feet to the Point of Beginning.
