RESOLUTION APPROVING ZONING PETITION

Wilcke, Agent, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RM-RESIDENTIAL MULTIPLE FAMILY DISTRICT (MEDIUM DENSITY) of the East 1/4 of the West 1/2 of the Northeast 1/4 of the Southwest 1/4 of Section 13, Township 46 South, Range 42 East; less right-of-way of record for Lake Worth Drainage District Lateral Canal No. 33, and less the rightof-way for State Road 806 (West Atlantic Avenue) as recorded in Road Plat Book 3, page 27, less and not including the South 330.0 feet Said property located approximately 300 feet north of Atlantic thereof. Avenue (Delray West Road, S.R. 806), approximately .3 mile east of Military Trail (S.R. 809), was approved as advertised.
