NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 29th day of January, 1976 , that petition the petition of MOBIL OIL CORPORATION by Charles No. 76-5, E. Barnthouse, Agent, for the REZONING, FROM CN-NEIGHBORHOOD COMMERCIAL DISTRICT TO CG-GENERAL COMMERCIAL DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW AN AUTO SERVICE STATION on a portion of the Northwest 1/4 of Section 9, Township 45 South, Range 43 East, more particularly described as follows: commence at the northeast corner of the Northwest 1/4 of said Section and run South 02° 45' 00" West along the East line of the Northwest 1/4 of said Section 9 for 53.015 feet; thence North 88° 38' 00" West parallel to the North Line of the Northwest 1/4 of said Section 9 for 40 feet to the Point of Beginning of the tract of land hereinafter described; thence continue North 88° 38' 00" West for 150.00 feet; thence South 02° 45' 00" West for 137.00 feet; thence South 88° 38' 00" East for 150.00 feet; thence North 02° 45' 00" East for 137.00 feet to the Point of Beginning; said tract of land containing 0.47
