Said property located at the southwest corner of Hypoluxo Road and San Castle Boulevard in a CG-General Commercial District, was approved as advertised, subject to the following special conditions:

1. Prior to the issuance of any building permits, the
Petitioner shall dedicate to Palm Beach County, the

additional right-of-way required to provide fifty-four (54) feet from the centerline for the Ultimate right-of-way for Hypoluxo Road.
