RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided **for** in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 76-111 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 23 September 1976.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session 1976 this 23 day of September , that petition 76-111 the petition of THE COPPOLA COMPANY by Kenneth G. No. Bacheller, President of Ridgewood Development Company, Agent, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RS-RESIDENTIAL SINGLE FAMILY DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A GOLF COURSE AND ACCESSORY USES on a parcel of land located in Section 25, Township 46 South, Range 42 East and Section 30, Township 46 South, Range 43 East, more particularly described as follows: The Southeast 1/4; and the South 3/4 of the Southwest 1/4; and the Northeast 1/4 of the Northeast 1/4 of the Southwest 1/4, lying South of Lateral 37, of Section 25, Township 46 South, Range 42 East; subject to the right-of-way for Military Trail (S.R. 809) and Lake Worth Drainage District right-of-ways; together with Tracts 10, 11, 12, 13, 14 and 15 of the subdivision of the Southwest 1/4 of Model Land Company's subdivision of the South 1/2 of Section 30, Township 46 South, Range 43 East, as recorded in Plat Book 6, page 52, subject to rights-ofway and easements of record; containing 340.57 acres more or less. Said property located on the east side of Military Trail (S.R. 809) approximately .5 mile south of Southwest 12th Street, was approved as advertised subject to the followinp special conditions:

- Prior to the issuance of any building permits the Developer shall convey to Palm Beach County, sixty (60) feet from centerline for the ultimate right-of-way for Military Trail (S.R. 809).
- 2. Developer shall construct a left turn lane on the North approach at the intersection of Military Trail (S.R. 809) and the development's entrance road.
