Rapaport, President, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RS-RESIDENTIAL SINGLE FAMILY DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A RECREATION FACILITY AND PRIVATE CLUB on the South 1/2 of Tract 81 and the West 95 feet of the South 1/2 of Tract 82; Together With, the abandoned 25 foot right-of-way lying West of and adjacent to the South 1/2 of said Tract 81, all in Block 74, and a part of Palm Beach Farms Company Plat No. 3, in Section 7, Township 47 South, Range 42 East, as recorded in Plat Eook 2, pages 45 to 54, inclusive; containing 3.97 acres.
