NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session , that petition 24th day of March, 1977 this the petition of JEFFREY E. DUFF for the REZONING, FROM No. 77-33 AG-AGRICULTURAL DISTRICT TO CN-NEIGHBORHOOD COMMERCIAL DISTRICT of a parcel of land in Lot 8, Block "I", REPLAT of LOXAHATCHEE DISTRICT SUBDIVISION LOXAHATCHEE GROVES, in Section 32, Township 43 South, Range 41 East, as recorded in Plat Book 12, Page 29, being more particularly described as follows: Commencing at the Intersection of the East line of said Lot 8, with the North right-of-way line of Florida State Road No. 80, thence Westerly along the said right-of-way line a distance of 138.89 feet to the Point of Beginning; thence continue Westerly along the said right-of-way line a distance of 200.0 feet to a point; thence Northerly parallel with the East line of said LOT 8, a distance of 300.0 feet to a point; thence Easterly, parallel with the North line of TRACT "I", a distance of 200.05 feet to a point; thence Southerly parallel with the East line of said LOT 8, a distance of 303.17 feet to the Point of Beginning; containing 1.38 acres.
