

RESOLUTION NO. R-77-590

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 77-49 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 26 May 1977

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 26th day of May, 1977, that petition No. 77-49 the petition of UNITED TECHNOLOGIES CORP, PRATT E WHITNEY AIRCRAFT GROUP GOVT. PRODUCTS DIVISION by R.B. Myers, Attorney, for a SPECIAL EXCEPTION TO ALLOW A HELIPAD on a parcel of land situate in part of Section 13 and 14, Township 41 South, Range 40 East, more particularly described as: commencing at the Southwest corner of said Section 14, thence Northerly along the Westerly line of Section 14, 2,212.70 feet to the existing centerline of the main service road; thence East (an assumed bearing and all other bearings relative thereto) along the centerline of the main service road 4,963.43 feet; thence North 0° 00' 45" East 129.02 feet to the point of beginning; thence continued North 0° 00' 45" East 200.0 feet; thence South 89° 59' 15" East 952.75 feet; thence South 0° 00' 45" West 200.0 feet; thence North 89° 59' 15" West 952.75 feet to the point of beginning. Said property located on the southwest side of Bee Line Highway (S. R. 710) approximately 11 miles west of the Sunshine Parkway in an IG-General Industrial District, was approved as advertised.
