No. 77–60 as Trustee, by Conrad W. Schaefer, Agent, for the RE-ZONING, FROM AG-AGRICULTURAL DISTRICT TO RE-RESIDENTIAL ESTATE DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A PLANNED UNIT DEVELOPMENT on the Southwest 1/4 of Section 34, Township 46 South, Range 42 East, less the West 1320 feet thereof, also less the Right-of-way for Clint Moore Road as per Deed Book 724, page 497. Said property located on the north side of Clint Moore Road approximately 1-1/2 miles west of Military Trail, was approved as advertised subject to the following special conditions:

1. Developer shall convey to Palm Beach County, sixty (60) feet from the centerline of Jog Road for the ultimate right-of-way.

2. Within ninety (90) days of Special Exception approval, the developer shall place one thousand (\$1,000.00) dollars in an escrow account with Palm Eeach County for their pro-rata share of construction of improvements to the left turn lane at Clint Moore Road and Military Trail. 3. Maximum density shall not exceed 0.645 dwelling units per acre.
