HELD for a SPECIAL EXCEPTION No, TO ALLOW A DAY CARE CENTER on commencing at the Northwest corner of the Northwest 1/4 of the Southwest 1/4 of Section 18, Township 44 South, Range 43 East; thence South a distance of 567 feet to a point; thence East a distance of 25 feet to the Point of Beginning; thence South a distance of 109.6 feet to a point; thence East a distance of 209 feet to a point; thence North a distance of 109.6 feet to a point; thence West a distance of 209 feet to the Point of Beginning. Containing 0.53 acres, more or less. Said property located at the Northeast corner of the intersection of Kirk Road and Dale Road in an RM-Residential Multiple Family District (Medium Density), was approved as advertised subject to the following special conditions:

1. Developer shall convey to Palm Beach County forty (40) feet from the centerline of Kirk Road for the ultimate right-of-way.
