Bills, Agent, for a SPECIAL EXCEPTION TO ALLOW A FINANCIAL INSTITUTION WITH DRIVE-UP TELLER WINDOWS AND AN ON-SITE WATER TREATMENT PLANT TO BE LOCATED WITHIN AN EXISTING PLANNED COMMERCIAL DEVELOPMENT KNOWN AS "JUNO SQUARE" on that portion of Palm Avenue, lying between the South line of Olive Street and the North line of Floral Street, excepting therefrom the part thereof which lies within 60 feet of each side of, measured at right angles to, the centerline of Survey of State Road No. 5, Section 9304-112, as shown on right-of-way map recorded in Road Plat Book 2, Page 114; that certain portion of a street designated as Oleander Avenue, which
