NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session 17th day of this November, 1977 , that petition No. \$7-163 the petition of EVERGLADES RIFLE AND PISTOL CLUB, INC., BY ALBERT VAN DER KOGEL, PRESIDENT FOR A SPECIAL EXCEPTION TO ALLOW A GUN CLUB FOR RIFLE AND PISTOL TARGET SHOOTING on that part of Section 8, Township 43 South, Range 40 East, described as follows: Commencing at a point on the North line of said Section 8, 1650.0 feet West of the Northeast corner thereof; thence South 01°56'58" West parallel with the East line of said Section, a distance of 1320.0 feet, to the Point of Beginning of the tract of land to be described; thence North 89° 38' 55" East, parallel with the North line of said Section, a distance of 990.00 feet; thence South 01° 56' 58" West parallel with the East line of said Section, a distance of 660.0 feet; thence South 89° 38'55" West parallel with the North line of said Section a distance of 990.0 feet; thence North 01°56'58" East, parallel with the East line of said Section 8, a distance of 660.0 feet to the Point of Beginning, SUBJECT to an easement over the West 30 feet thereof for Road purposes, and, over the South 7.5 feet, for F.P. & L.
