## RESOLUTION APPROVING ZONING PETITION

FRANK for the REZONING, FROM RM-RESIDENTIAL MULTIPLE FAMILY DISTRICT (Medium Density) TO CG-GENERAL COMMERCIAL DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A COMMERCIAL NEW AND USED, RECREATIONAL VEHICLE SALE, RENTAL REPAIR FACILITY AND LOT on The East 1/2 of the West 1/2 of the East 1/2 of the East 1/2 of the Northeast 1/4, and the West 29.98 feet of the East 1/2 of the East 1/2 of the East 1/2 of the Northeast 1/4 all being in Section 24, Township 42 South, Range 42 East, Less the South 2260.21 feet thereof and less the limited access right-of-way of State Road No. 9, also less the right-of-way of State Road 809A.
