Jones, Esquire for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RS-RESIDENTIAL SINGLE FAMILY DISTRICT of a parcel of land in Section 34, Township 43 South, Range 41 East, being more particularly described as follows: Commencing at the Northeast Corner of said Section 34, run South 0° 00' 35" West 3695.80 feet to a point on the North rightof-way of State Road 80; thence run North 89°40'48" West along the North right-of-way of State Road 80, 991.87 feet to the Point of Beginning; thence continue North 89° 40' 48" West 1650.00 Feet to a point; thence run North 0° 05' 19" East 527.66 feet to a point; thence run South 89° 40' 48" East 1652.14 feet to a point; thence run South 0° 19' 12" West 527.56 feet to the Point of Beginning.
