RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 1'63 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided **for** in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance **No.** 73-2 have been satisfied; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session 29th December, 1977 the day of , that petition the petition of ISIDOR MOSKOWITZ for the REZONING, No.77-182 FROM RM-RESIDENTIAL MULTIPLE FAMILY DISTRICT (MEDIUM DENSITY) TO CG-GENERAL COMMERCIAL DISTRICT, of the East 100 feet of the North 1/2 of Tract 5, Block 4, Plat No. 1, Palm Beach Plantations, in Section 12, Township 44 South, Range 42 East, as recorded in Plat Eook 10, Said property located on the south side of Forest Hill Boulevard, approximately 1/4 mile west of Kirk Road, was approved as amended to rezone to CS-Specialized Commercial District with the further Special Exception for a Planned Commercial Development, subject to the following special conditions:

1. Within ninety (90) days of the Special Exception approval the Developer shall convey to Palm Eeach County an additional twenty-seven (27) feet to provide for the ultimate right-of-way of sixty (60) feet from the centerline of Forest Hill Eoulevard.

2. Within thirty (30) days of the Special Exception approval the Developer shall submit a site plan to the Department of Planning, Zoning and Building.
