

RESOLUTION NO. R-78-709

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No, 78-90 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 25 May 1978.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session the 25th day of May, 1978, that petition No. 78-90 the petition of DANNY GERALD BAILEY and JANE CASEY by Danny Gerald Bailey, Individually and as Agent, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RS-RESIDENTIAL SINGLE FAMILY DISTRICT of the West 250 feet of the East 290 feet, of the South 168.10 feet of that portion of the East 1/2 of the Northwest 1/4 of the Northeast 1/4 of Section 35, Township 41 South, Range 42 East, lying North of Hood Road, together with an ingress and egress easement over and across the West 20.0 feet thereof; and the West 250 feet of the East 290 feet of the North 161.90 feet of the South 330 feet of that portion of the East 1/2 of the Northwest 1/4 of the Northeast 1/4 of Section 35, lying North of Mood Road; together with an ingress and egress easement over and across the West 20.0 feet thereof. Said property located on the north side of Hood Road approximately .7 mile west of Military Trail, was approved as advertised.

Commissioner Koehler, moved for approval of the petition.
