## RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 16.3 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 78-124 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 27 July 1978.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-SIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session July, 1978 27th day of , that petition t h e 78-124 the petition of DANIEL L. BAKST, TRUSTEE, for a No. SPECIAL EXCEPTION TO ALLOW A FINANCIAL INSTITUTION WITH DRIVE-UP TELLER WINDOWS on Lots 9, 10 E 11, less the East 3 feet thereof, Plat of East View Estates, in Section 25, Township 43 South, Range 42 East, as recorded in Plat Book 18, page 18. Said property located on the west side of Military Trail, approximately .2 mile south of Okeechobee Road in a CG-General Commercial District, was approved as advertised subject to the following conditions:

- 1. Petitioner shall pave Elmhurst Road to the west property line, pavement to be aligned with Westgate Avenue on the east side of Military Trail.
- 2. Petitioner shall construct a left turn lane, west approach, on Elmhurst Road at Military Trail.
- 3. Within ninety (90) days of the Special Exception approval, petitioner shall convey to Palm Beach County an additional seven (7) feet for the ultimate right-of-way for Military Trail.

- 4. Within ninety (90) days of the Special Exception approval, petitioner shall convey to Palm Beach County an additional ten (10) feet **for** the ultimate right-of-way for Elmhurst Road.
- 5. Within ninety (90) days of the Special Exception approval, petitioner shall convey to Palm Beach County a safe corner at the northwest corner of Military Trail and Elmhurst Road.
