Trettien, Agent, for a SPECIAL EXCEPTION TO ALLOW AN EDUCATIONAL INSTITUTION on that part of Lot 6, according to the plat of Subdivision of Government Lot 8 of Section 4, Township 42 South, Range 43 East, as recorded in Plat Book 18, page 4, described as follows: Begin at the Southwest corner of Lat 6 of said Subdivision, run Northerly along the Easterly right-of-way line of the Ellison Wilson Road a distance of 125 feet; thence Easterly and parallel to the South line of Lot 6 a distance of 200 feet; thence continue South a distance of 125 feet to the South line of said Lot 6; thence continue Westerly along the South line of Lot 6, a distance of 200 feet to the Point of Beginning.
