Watson, Agent, for the REZONING, FROM RH-RESIDENTIAL MULTIPLE FAMILY DISTRICT (HIGH DENSITY) TO CG-GENERAL COMMERCIAL DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW COMMERCIAL NEW AND USED AUTO-MOBILE SALES AND RENTAL LOT WITH REPAIR FACILITY, INCLUDING AN AUTO PAINT AND BODY FACILITY AND CAR WASH on Lots 1 through 15, inclusive, together with Lots 31 through 45, inclusive, Block 9, Westgate Estates (Northern Section), in Section 30, Township 43 South, Range 43 East, as recorded in Plat Book 8, page 38; subject to easements, reservations and rightsof-way of record. - 4. Petitioner shall pave Shawnee Avenue from Tallahassee Drive to the east property line.
