McMurrain, Agent, for the REZONING, HROM AG-AGRICULTURAL DISTRICT, IN PART, AND CN-NEIGHBORHOOD COMMERCIAL DISTRICT, IN PART, TO CG-GENERAL COMMERCIAL DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A FINANCIAL INSTITUTION WITH DRIVE-UP TELLER WINDOWS on the West 1/2 of the Northwest 1/4 of the Northwest 1/4 of the Northwest 1/4 of Section 25, Township 45 South, Range 42 East, less road rights-of-way Said property located on the southeast corner of the intersection of record, of Boynton Road (S.R. 804) and Military Trail (S.R. 809), was approved as advertised subject to the following conditions:

- 1. Within ninety (90) days of the Special Exception approval, petitioner shall convey to Palm Beach County:
 - a. Sixty (60) feet from the centerline for Military Trail
 - right-of-way.

 b. Sixty (60) feet from the centerline for Boynton West Road (S.R. 804) right-of-way.
 - c. Twenty-five (25) foot safe corner lot at the southeast corner of Military Trail and Boynton West Road.

- 2. Petitioner shall construct a left turn lane, north approach, on Military Trail at the development's entrance.
- 3. Petitioner shall lengthen the existing left turn lane, east approach, on Boynton West Road at Military Trail easterly to provide for a seventy-five (75) foot storage lane on Boynton West Road, east approach, at the development's entrance.
