EDWARDS for a SPECIAL EXCEPTION No. TO ALLOW THE PARKING OF ONE (1) MOBILE HOME AS A TEMPORARY RESIDENCE on a parcel of land in Tract 25, Block 'F', Loxahatchee Groves, in Section 21, Township 43 South, Range 41 East, said parcel being more particularly described as follows: the West 1/2 of the South 1/2 of said Tract 25, as recorded in Plat Book 12, page 29; subject to an easement for utilities and drainage over the South 15 feet thereof, together with an easement for road purposes over the South 25 feet of the South 1/2 of the East 1/2; and an easement for road purposes over the East 20 feet of the West 1/2 of the South 1/2. Said property located approximately 600 feet west of 'G' Road, and approximately .7 mile north of Okeechobee Road (S.R. 704) in an AG-Agricultural District, was approved as advertised subject to the following condition:

1. The term of the Special Exception allowing the parking of the mobile home as a temporary residence shall be limited to a maximum of five (5) years because of the changing character of the area.
