Seifert, No. 79 - 4Pastor, for a SPECIAL EXCEPTION TO ALLOW A CHURCH AND ACCESSORY BUILDINGS AND STRUCTURES on the West 95.75 feet of Lot 9, all of Lots 10 and 11, Block 3, LAGUNA PARK, PLAT NO. 2, in Section 7, Township 44 South, Range 43 East, as recorded in Plat Book 21, page 65. Said property located on the south side of Melaleuca Drive, approximately .2 mile west of Congress Avenue (S.R. 807) in an RM-Residential Multiple Family District (Medium Density), was approved as advertised subject to the following conditions:

- 1. Within ninety (90) days of Special Exception approval, petitioner shall convey to Palm Beach County thirty (30) feet from the centerline of Melaleuca Road.
- 2. Petitioner shall convey to the Lake Worth Drainage District, the South fifteen (15) feet of the West ninety-five and three quarter (95.75) feet of Lot nine (9), the South fifteen (15) feet of Lots ten (10) and eleven (11), all in Block three (3), Laguna Park, Plat No. 2, P.B. 21, page 65, for the right-of-way for Lateral Canal No. 7. This conveyance may be by Quit Claim Deed or Easement, whichever the owner prefers.
- 3. The seating capacity of the proposed church shall not exceed two hundred and fifty (250).
- 4. The parking **row** along the north property line as designated on the site plan submitted (Exhibit #12) shall be grassed and used for excess parking. This area must be maintained as lawn.
