BOONE, by Edward Boone, Agent, No. for a SPECIAL EXCEPTION TO ALLOW ONE (1) MOBILE HOME AS A TEMPORARY RESIDENCE on the East 1/2 of the following described property: Beginning at the Northeast corner of Section 8, Township 43 South, Range 40 East, thence South 89°38'55" West along the North line of said Section 8, a distance of 660 feet to a point; thence South 01°56'58" West parallel with the East line of said Section 8, a distance of 660 feet to a point; thence North 89°38'55" East parallel with the North line of said Section 8, a distance of 660 feet, to the East line of said Section 8, thence North 01°56'58" East along the East line of said Section 8, a distance of 660 feet to the Point and Place of Beginning; subject to an easement over the North 100 feet thereof and over the East 30 feet thereof. Said property located approximately five (5) miles north of Southern Boulevard, and approximately ten (10) miles west of S.R. 7 (U.S. 441) in an AG-Agricultural District, was approved as advertised subject to the following condition:
