Fotorny, Agent, No. 79 - 39for the REZONING, HROM AG-AGRICULTURAL DISTRICT TO IL-LIGHT INDUSTRIAL DISTRICT of the North 1/2 of the Southwest 1/4 of the Northwest 1/4 of the Northeast 1/4 (less the North 25 feet and the West 50 feet thereof for road purposes) in Section 1, Township 43 South, Range 42 East, together with an easement for purposes of ingress and egress in common with the grantor and others over those parcels described and set forth in Official Record Book 214, page 350, and Official Record Book 214, page 351, described as follows: a perpetual easement for purposes of ingress and egress over a strip of land 50 feet in width lying 25 feet on each side of the following described centerline: The South line of the North 1/4 of the Northeast 1/4 of said Section 1, less the East 666.89 feet thereof; also, a perpetual easement for ingress and egress over a strip of land 50 feet in width lying 25 feet on each side of the following described centerline: the South line of the North 1/2 of the Northeast 1/4 of said Section 1, less the East 670.33 feet thereof.
