Samra, Jr., Agent, for a SPECIAL EXCEPTION TO ALLOW A DAYCARE CENTER on the North 438.2 feet of the East 1/2 of the East 1/2 of the Southeast 1/4 of the Northwest 1/4, in Section 8, Township 44 South, Range 43 East, less the North 146.08 feet thereof. Said property located on the west side of Florida Mango Road, approximately .3 mile north of Forest Hill Boulevard (S.R. 882) in an RS-Residential Single Family District, was approved as advertised subject to the following conditions:

- 1. Within ninety (90) days of the Special Exception approval, petitioner shall convey to Palm Beach County forty (40) feet from the centerline of Fla-Mango Road.
- 2. Petitioner shall align a new turnout at the southerly parking area with Lin Mar Drive.
- 3. Petitioner shall provide a grass play area subject to Code regulations.
- 4. Petitioner shall provide additional landscaping of all perimeter areas surrounding the subject facility, subject to the approval of the Department of Planning, Zoning and Building.
