Subject to easement for drainage over the West 12.0 feet thereof. Said property located on the west side of 161st Terrace North, approximately 1.6 mile north of Okeechobee Road and .4 mile east of Seminole-Pratt Whitney Road in an AG-Agricultural District, was approved as advertised subject to the following condition:

1. The term of the Special Exception allowing the parking of the mobile home as a temporary residence shall be limited to a maximum of five (5) years because of the changing character of the area.
