WALKER for the REZONING, FROM No. AG-AGRICULTURAL DISTRICT TO RE-RESIDENTIAL ESTATE DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW THE EXCAVATION AND REMOVAL OF SHELL, MARL OR OTHER EXTRACTIVE MATERIALS on Tracts 29, 30, 31 and 32, Block 44 of Palm Beach Farms Company Plat No. 2, in Section 12, Township 45 South, Range 41 East, as recorded in Plat Book 2, page 49, together with the South 1/2 of the Southwest 1/4 of Section 12, Township 45 South, Range Said property located on the northwest side of U.S. 441 (S.R. 7) and 80th Street South, approximately .6 mile south of Heritage Road (71st Street), was approved as advertised subject to the following conditions:
