SABARRA, No. M.D., for the REZONING, FROM RM-RESIDENTIAL MULTIPLE FAMILY DISTRICT (MEDIUM DENSITY), IN PART, AND CN-NEIGHBORHOOD COMMERCIAL' DISTRICT, IN PART, TO CS-SPECIALIZED COMMERCIAL DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW AN ON-SITE WATER TREATMENT FACILITY on the West 150 feet of Lot A, less the North 35 feet for road right-of-way, and the West 150 feet of Lot B, in Block 4, according to Palm Beach Farms Company Plat No. 7, being in Section 30, Township 44 South, Range 43 East, as recorded in Plat Book 5, page 72.
