RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

HEIL for a SPECIAL EXCEPTION No. TO ALLOW THE PARKING OF ONE (1) MOBILE HOME AS A TEMPORARY RESIDENCE on the North 1/2 of the Southwest 1/4 of the Southwest 1/4 of the Northeast 1/4 of Section 14, Township 45 South, Range 41 East; together with an easement for ingress-egress over the North 30 feet of the East 3/4 of the South 1/2 of the South 1/2 of the Northeast 1/4 of said Section 14, together with a non-exclusive easement for ingress and egress over the North 50 feet of the South 1/2 of the North 1/2 of Section 13, and a non-exclusive right of ingress and egress over the property on which Florida Power and Light Company presently holds an easement, subject however to the easement rights of Florida Power and Light Company. Said property located .1 mile on the west side of U.S. 441 (S.R. 7), approximately .4 mile east of University Expressway (Pratt-Whitney Road) in an AG-Agricultural District, was approved as advertised subject to the following condition:

1. The term of the Special Exception allowing the parking of the mobile home as a temporary residence shall be limited to a maximum of five (5) years because of the changing character of the area.
