Gann, Attorney, for a SPECIAL EXCEPTION TO ALLOW GASOLIME PUMP ISLAND FACILITIES on a parcel of land more particularly described as for the Point of Beginning commence at the Northwest corner of Lot 74, according to the plat of a Resubdivision of Lots 1, 2, 3, 4, 5, 6, 7 and 74 of the VICTOR L. GEIGER SECOND ADDITION, in Section 26, Township 42 South, Range 36 Fast, as recorded in Plat Book 23, page 39; thence South 4043'15" East along the Easterly right-of-way line of Loop Road, being a County Road, a distance of 567.84 feet to a point; thence North 67°49'01" East, a distance of 124.74 feet to the intersection thereof with the Westerly right-of-way line of State Road No. 717 and the intersection of a curve concave to the East, having a radius of 1985.08 feet, a Central Angle of 15°44'22", and a chord hearing of North 17°21'53" West; thence Northwesterly and Northerly along the arc of said curve
