Beach Farms Company, Plat No. 3, in Section 18, Township 47 South, Range 42 East, as recorded in Plat Book 2, pages 45 through 54, inclusive, less the South 25 feet thereof and the East 29 feet thereof for road right-of-way purposes, Said property located at the northwest corner of the intersection of Boca Raton Road West (S.R. 808) and 90th Avenue South, approximately one (1) mile east of S.R. 7, was approved as advertised subject to the following conditions:
