Van Lennep, President, for a SPECIAL EXCEPTION TO ALLOW A COMMERCIAL STABLE AND HORSE BREEDING AND TRAINING FARM INCLUDING A WATER TREATMENT FACILITY on the South 1/2 of Tracts 39 and 40, all of Tracts 41, 42, 55, 56, 57, 58 and 59, in Section 30, Township 46 South, Range 42 East, Palm Beach Farms Company Plat No. 1, as recorded in Plat Rook 2, page 27.
